Delaney, IV, James V. Parolisi, Robert W. Luckow, Robert A. Johnson, Jr., Richard P. Volpe, and Robert A. Scavone, Jr., are barred from association with any broker or dealer; and it further ordered that the allegations that Respondents violated Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder are dismissed.

Foley, II, Scott G. Hunt, Frank A. Delaney, IV, Robert A. Johnson, Jr., Richard P. Volpe, and Robert A. Scavone, Jr., unless the NYSE has done so on its own accord.
