Pursuant to Commission Rule of Practice 411,<sup>1</sup> the petitions for review by James E. Cohen and Joseph A. Corazzi (collectively, "Respondents") and the cross-petition for review by the Division of Enforcement of the administrative law judge's initial decision<sup>2</sup> are granted. Pursuant to Rule of Practice 411(d),<sup>3</sup> the Commission will determine what sanctions, if any, are appropriate in this matter.

Accordingly, IT IS ORDERED, pursuant to Rule of Practice 450(a),<sup>4</sup> that Respondents shall file a joint brief in support of their petitions for review by November 25, 2015. The Division shall file a brief in opposition and in support of its cross-petition for review by

December 28, 2015. Respondents shall file any joint reply brief, which shall not exceed 9,000 words, by January 11, 2016.<sup>5</sup> Pursuant to Rule of Practice 180(c), failure to file a brief in support of the petition may result in dismissal of this review proceeding as to that petitioner.<sup>6</sup>
