ORDER GRANTING PETITION FOR REVIEW AND SCHEDULING BRIEFS

Pursuant to Commission Rule of Practice 411,<sup>1</sup> the petition of Laurie Bebo for review of the administrative law judge's initial decision<sup>2</sup> is granted. Bebo also requests relief from the word limits in Rule of Practice 450(c).<sup>3</sup> That request is granted in part. Pursuant to Rule of Practice 411(d),<sup>4</sup> the Commission will determine what sanctions, if any, are appropriate in this matter.

Accordingly, IT IS ORDERED, pursuant to Rule of Practice 450(c), that briefs be filed as follows:

<u>Respondent's opening brief</u>: Respondent shall file a brief, not to exceed 21,000 words, by January 7, 2016.

<u>Division's opposition brief</u>: Enforcement shall file a brief, not to exceed 21,000 words by February 8, 2016.

<u>Respondent's reply brief</u>: Respondent shall file a brief, not to exceed 10,500 words by February 22, 2016.<sup>5</sup>
