**ORDER VACATING MUNICIPAL SECURITIES DEALER, MUNICIPAL ADVISOR,  
TRANSFER AGENT, AND NATIONALLY RECOGNIZED STATISTICAL RATING  
ORGANIZATION BARS**

James R. Holdman seeks to vacate an order, dated July 15, 2015 (the “Order”), to the extent that it bars him from association with a municipal securities dealer, municipal advisor, transfer agent, or nationally recognized statistical rating organization.<sup>1</sup> The bars at issue were imposed based solely on conduct occurring prior to July 22, 2010, the effective date of the Dodd-Frank Wall Street Reform and Consumer Protection Act.<sup>2</sup> Accordingly, in our discretion, we vacate the Order to the extent it prohibits James R. Holdman from associating with a municipal securities dealer, municipal advisor, transfer agent, or nationally recognized statistical rating organization, but otherwise leave the Order unmodified.
