ORDER TO SHOW CAUSE

On December 26, 2018, the Securities and Exchange Commission issued an order instituting administrative proceedings (“OIP”) against John Sherman Jumper pursuant to Section 15(b) of the Securities Exchange Act of 1934 and Section 203(f) of the Investment Advisers Act of 1940.¹ On February 22, 2019, the Division of Enforcement filed the Rule 141 Notice and Proof of Service of OIP, which states that service of the OIP was made on Jumper on February 14, 2019, pursuant to Rule 141(a)(2)(i) of the Commission’s Rules of Practice.²

As stated in the OIP, Jumper’s answer was required to be filed within 20 days of service of the OIP.³ As of the date of this order, Jumper has not filed an answer. The prehearing conference and the hearing are thus continued indefinitely.

Accordingly, Jumper is ORDERED to SHOW CAUSE by June 28, 2019, why he should not be deemed to be in default and why this proceeding should not be determined against him due to his failure to file an answer and to otherwise defend this proceeding. When a party defaults, the allegations in the OIP will be deemed to be true and the Commission may determine the proceeding against that party upon consideration of the record without holding a public hearing.⁴ The OIP informed Jumper that a failure to file an answer could result in him being deemed in default and the proceedings determined against him.⁵

If Jumper files a response to this order to show cause, the Division may file a reply within 14 days after its service. If Jumper does not file a response, the Division shall file a motion for default and other relief by July 26, 2019. The motion for default and other relief may be accompanied by additional evidence pertinent to the Commission's individualized assessment of whether the requested relief is appropriate and in the public interest.⁶ The parties may file opposition and reply briefs within the deadlines provided by the Rules of Practice.⁷ The failure to timely oppose a dispositive motion is itself a basis for a finding of default;⁸ it may result in the determination of particular claims, or the proceeding as a whole, adversely to the non-moving party and may be deemed a forfeiture of arguments that could have been raised at that time.⁹

Upon review of the filings in response to this order, the Commission will either direct further proceedings by subsequent order or issue a final opinion and order resolving the matter.
