ORDER TO SHOW CAUSE

The Securities and Exchange Commission ("Commission") issued an order instituting administrative proceedings ("OIP") on April 22, 2019, pursuant to Section 15(b) of the Securities Exchange Act of 1934 and Section 203(f) of the Investment Advisers Act of 1940, against Charles Myrick Winstead. On May 22, 2019, the Division of Enforcement filed a Declaration of Andrew O. Schiff, which states that service of the OIP was made on Winstead on May 8, 2019, consistent with Rule 141(a)(2)(i) of the Commission's Rules of Practice.²

As stated in the OIP, Winstead's answer was required to be filed within 20 days of service of the OIP.³ As of the date of this order, Winstead has not filed an answer. The prehearing conference and the hearing are thus continued indefinitely.

Accordingly, Winstead is ORDERED to SHOW CAUSE by October 14, 2019, why he should not be deemed to be in default and why this proceeding should not be determined against him due to his failure to file an answer and to otherwise defend this proceeding. Winstead shall

deliver any response to the proper prison authorities, including any answer, no later than the due date, for forwarding to the Commission's Office of the Secretary.⁴

When a party defaults, the allegations in the OIP will be deemed to be true and the Commission may determine the proceeding against that party upon consideration of the record without holding a public hearing.⁵ The OIP informed Winstead that a failure to file an answer could result in him being deemed in default and the proceedings determined against him.⁶

If Winstead files a response to this order to show cause, the Division may file a reply within 14 days after its service. If Winstead does not file a response, the Division shall file a motion for default and other relief by October 28, 2019. The motion for default and other relief may be accompanied by additional evidence pertinent to the Commission's individualized assessment of whether the requested relief is appropriate and in the public interest. The parties may file opposition and reply briefs within the deadlines provided by the Rules of Practice. The failure to timely oppose a dispositive motion is itself a basis for a finding of default; it may result in the determination of particular claims, or the proceeding as a whole, adversely to the
