ORDER TO SHOW CAUSE

On July 3, 2019, the Securities and Exchange Commission issued an order instituting administrative proceedings (“OIP”) against Alexander Charles White pursuant to Section 15(b) of the Securities Exchange Act of 1934.¹ On July 11, 2019, the Division of Enforcement filed a Rule 141 Notice and Proof of Service, which states that service of the OIP was made on White on July 5, 2019, pursuant to Rule 141(a)(2)(i) of the Commission’s Rules of Practice.²

As stated in the OIP, White’s answer was required to be filed within 20 days of service of the OIP.³ As of the date of this order, White has not filed an answer. The prehearing conference and the hearing are thus continued indefinitely.

Accordingly, White is ORDERED to SHOW CAUSE by September 12, 2019, why he should not be deemed to be in default and why this proceeding should not be determined against him due to his failure to file an answer and to otherwise defend this proceeding. When a party defaults, the allegations in the OIP will be deemed to be true and the Commission may determine the proceeding against that party upon consideration of the record without holding a public hearing.⁴ The OIP informed White that a failure to file an answer could result in him being deemed in default and the proceedings determined against him.⁵

If White files a response to this order to show cause, the Division may file a reply within 14 days after its service. If White does not file a response, the Division shall file a motion for default and other relief by October 10, 2019. The motion for default and other relief may be accompanied by additional evidence pertinent to the Commission's individualized assessment of whether the requested relief is appropriate and in the public interest.⁶ The parties may file opposition and reply briefs within the deadlines provided by the Rules of Practice.⁷ The failure to timely oppose a dispositive motion is itself a basis for a finding of default;⁸ it may result in the determination of particular claims, or the proceeding as a whole, adversely to the non-moving party and may be deemed a forfeiture of arguments that could have been raised at that time.⁹

Upon review of the filings in response to this order, the Commission will either direct further proceedings by subsequent order or issue a final opinion and order resolving the matter.
