## ORDER REGARDING SERVICE AS TO REFCO PUBLIC COMMODITY POOL, L.P.

The Securities and Exchange Commission ("Commission") issued an Order Instituting Proceedings ("OIP") on September 24, 2019, pursuant to Section 12(j) of the Securities Exchange Act of 1934, against respondents RARAN Corporation, Refco Public Commodity Pool, L.P., and Rent USA, Inc.<sup>1</sup>

On December 11, 2020, the Commission issued an Order to Show Cause as to RARAN and Rent USA.<sup>2</sup> This order also directed the Division of Enforcement to attempt service on Refco at the address listed on its July 6, 2010 Schedule 14D-9, and to file a declaration demonstrating this attempted service.<sup>3</sup> To date, no such declaration has been filed.

Accordingly, it is ORDERED that the Division file a status report concerning service of the OIP on Refco by March 5, 2021, and every 28 days thereafter until service is accomplished.

The parties' attention is called to the Commission's March 18, 2020 order regarding the filing and service of papers, which provides that pending further order of the Commission parties to the extent possible shall submit all filings electronically at <a href="mailto:apfilings@sec.gov">apfilings@sec.gov</a>.
