ORDER REGARDING SERVICE

The Securities and Exchange Commission ("Commission") issued an Order Instituting Proceedings ("OIP") on September 14, 2020, against Quest Entertainment Corp. ("Respondent") pursuant to Section 12(j) of the Securities Exchange Act of 1934.¹

On December 31, 2020, the Division of Enforcement filed a Declaration of Victor Tabak, which stated that service of the OIP was made on Respondent by a mailing "to the address shown on its most recent EDGAR filing." The Declaration also states that Respondent's most recent filing with the Commission "was a Form 10 filed with the Commission on August 13, 1992." However, the Commission's EDGAR database does not contain such a filing.²

Accordingly, by July 6, 2021, the Division is ordered to file a status update that attaches (1) a corrected declaration regarding its service of the OIP on Respondent and (2) Respondent's most recent filing with the Commission.³

The parties' attention is called to the Commission's March 18, 2020 order regarding the filing and service of papers, which provides that pending further order of the Commission parties

to the extent possible shall submit all filings electronically at <u>apfilings@sec.gov</u>.⁴ Also, the Commission's Rules of Practice were recently amended to include new e-filing requirements, which took effect on April 12, 2021.⁵
