ORDER TO SHOW CAUSE

On November 5, 2020, the Securities and Exchange Commission issued an order instituting administrative proceedings (“OIP”) against Conrad A. Coggeshall pursuant to Section 15(b) of the Securities Exchange Act of 1934 and Section 203(f) of the Investment Advisers Act of 1940.¹ On March 11, 2021, the Division of Enforcement filed an Affirmation of Payson Constable Tony McDaniel, which establishes that service of the OIP was made on Coggeshall on November 20, 2020, pursuant to Rule 141(a)(2)(i) of the Commission’s Rules of Practice.²

As stated in the OIP, Coggeshall’s answer was required to be filed within 20 days of service of the OIP.³ As of the date of this order, Coggeshall has not filed an answer. The prehearing conference and the hearing are thus continued indefinitely.

Accordingly, Coggeshall is ORDERED to SHOW CAUSE by November 8, 2021, why he should not be deemed to be in default and why this proceeding should not be determined against him due to his failure to file an answer and to otherwise defend this proceeding. Coggeshall’s submission shall address the reasons for his failure to timely file an answer, and include a proposed answer to be accepted in the event that the Commission does not enter a default against him.

When a party defaults, the allegations in the OIP will be deemed to be true and the Commission may determine the proceeding against that party upon consideration of the record without holding a public hearing.⁴ The OIP informed Coggeshall that a failure to file an answer could result in him being deemed in default and the proceedings determined against him.⁵

If Coggeshall files a response to this order to show cause, the Division may file a reply within 14 days after its service. If Coggeshall does not file a response, the Division shall file a motion for entry of an order of default and the imposition of remedial sanctions by December 6, 2021. The motion for sanctions should address each statutory element of the relevant provisions of Section 15(b) of the Exchange Act and Section 203(f) of the Advisers Act.⁶ The motion should discuss relevant authority relating to the legal basis for, and the appropriateness of, the requested sanctions and include evidentiary support sufficient to make an individualized assessment of whether those sanctions are in the public interest.⁷ The parties may file opposition and reply briefs within the deadlines provided by the Rules of Practice.⁸ The failure to timely oppose a dispositive motion is itself a basis for a finding of default;⁹ it may result in the

determination of particular claims, or the proceeding as a whole, adversely to the non-moving party and may be deemed a forfeiture of arguments that could have been raised at that time.¹⁰

The parties' attention is directed to the most recent amendments to the Commission's Rules of Practice, which took effect on April 12, 2021, and which include new e-filing requirements.¹¹

Upon review of the filings in response to this order, the Commission will either direct further proceedings by subsequent order or issue a final opinion and order resolving the matter.
