ORDER REGARDING SERVICE

The Securities and Exchange Commission ("Commission") issued an order instituting administrative proceedings ("OIP") on May 10, 2022, pursuant to Section 15(b) of the Securities Exchange Act of 1934 and Section 203(f) of the Investment Advisers Act of 1940, against Robert Charles High, II.¹ It appears that there have been no filings in this proceeding since issuance of the OIP as to whether the OIP was served upon High. To assist the Office of the Secretary in maintaining a record of service that establishes that the OIP has been properly served, ² IT IS ORDERED that the Division of Enforcement file a status report concerning service of the OIP by August 1, 2022, and every 28 days thereafter until service is accomplished.

The parties' attention is directed to the most recent amendments to the Commission's Rules of Practice, which took effect on April 12, 2021, and which include new e-filing requirements.³
