ORDER DIRECTING SUBMISSION FROM THE DIVISION OF ENFORCEMENT

On June 30, 2022, the Securities and Exchange Commission issued an Order Instituting Administrative Proceedings ("OIP") against the Northgate Nobles GreenhouseABE Foreign Grantor Trust (the "Trust") pursuant to Section 17A(c)(3) of the Securities Exchange Act of 1934.¹ On August 5, 2022, the Trust was ordered to show cause by August 19, 2022 why it should not be deemed to be in default and why this proceeding should not be determined against it due to its failure to file an answer and to otherwise defend this proceeding.² The order to show cause also directed the Division of Enforcement, in the event that the Trust did not file a response to the order, to file a motion for default and other relief by September 16, 2022.³

The show cause deadline passed without any filing by the Trust. Yet the Division has not moved for default and other relief by the deadline for doing so. The Division of Enforcement is thus ORDERED to file a motion for default and other relief by October 7, 2022, to be accompanied by additional evidence pertinent to the Commission's individualized assessment of whether the requested relief is in the public interest.⁴ The Division's motion must further explain

with reference to specific Commission rules how the records that the OIP alleged that Commission staff had sought from the Trust were "required records" under Commission rules.⁵ The parties thereafter may file opposition and reply briefs in response to the motion for default and other relief within the deadlines provided by the Rules of Practice.⁶ The failure to timely oppose a dispositive motion is itself a basis for a finding of default;⁷ it may result in the determination of particular claims, or the proceeding as a whole, adversely to the non-moving party and may be deemed a forfeiture of arguments that could have been raised at that time.⁸

The parties' attention is directed to the most recent amendments to the Commission's Rules of Practice, which took effect on April 12, 2021, and which include e-filing requirements.⁹
