ORDER SCHEDULING BRIEFS

Wilfredo Felix filed an application, pursuant to Section 19(d)(2) of the Securities Exchange Act of 1934,<sup>1</sup> for review of action taken against him by the Financial Industry Regulatory Authority ("FINRA"). FINRA filed a copy of the index to the record on November 28, 2022, pursuant to Rule 420(e) of the Rules of Practice.<sup>2</sup>

Accordingly, IT IS ORDERED, pursuant to Rule 450(a) of the Rules of Practice,<sup>3</sup> that a brief in support of the application for review shall be filed by January 18, 2023. A brief in

opposition shall be filed by February 17, 2023, and any reply brief shall be filed by March 3, 2023.<sup>4</sup> Pursuant to Rule 180(c) of the Rules of Practice, failure to file a brief in support of the application may result in dismissal of this review proceeding.<sup>5</sup>
