## THIRD SUPPLEMENTAL ORDER REGARDING SERVICE

On July 1, 2020, the Securities and Exchange Commission issued an order instituting administrative proceedings ("OIP") against Neil Burkholz pursuant to Section 203(f) of the Investment Advisers Act of 1940.<sup>1</sup> It appears that there have been no other filings in this proceeding since issuance of the OIP, including as to whether the OIP was served upon Burkholz.

The Commission has issued three previous orders regarding service—on October 19, 2021, December 13, 2021, and March 29, 2022—directing the Division of Enforcement to file periodic status reports concerning service of the OIP until service was accomplished.<sup>2</sup> To date, no status report has been filed, nor has the Division otherwise responded to the October 19, 2021, December 13, 2021, or March 29, 2022 orders.

Accordingly, IT IS ORDERED that the Division file a status report concerning service of the OIP on Burkholz by September 13, 2022, and every 28 days thereafter until service is accomplished.
