ORDER REGARDING SERVICE

On July 14, 2023, the Securities and Exchange Commission issued an order instituting proceedings (“OIP”) against Ronald Shane Flynn (“Respondent”) pursuant to Section 15(b) of the Securities Exchange Act of 1934.¹ It appears that, other than a notice of appearance by Division of Enforcement counsel, there have been no filings in this proceeding since issuance of the OIP, including as to whether the OIP was served upon Respondent. To assist the Office of the Secretary in maintaining a record of service that establishes that the OIP has been properly served,² IT IS ORDERED that the Division of Enforcement file a status report concerning service of the OIP by September 29, 2023, and every 28 days thereafter until service is accomplished.

The parties’ attention is directed to the e-filing requirements in the Rules of Practice.³
