ORDER REGARDING SERVICE

On September 4, 2024, the Securities and Exchange Commission issued an order instituting proceedings ("OIP") against Powertech Industries Inc. ("Respondent") pursuant to Section 12(j) of the Securities Exchange Act of 1934.¹

On October 2, 2024, the Division of Enforcement filed a Declaration of Gina Joyce, stating that, consistent with Rule 141(a)(2)(ii) of the Commission's Rules of Practice, service was made on Respondent on September 23, 2024, by mailing the OIP "to the address shown on its most recent EDGAR filing." However, the Commission's public EDGAR database does not include any filings by Respondent.² Accordingly, by November 13, 2024, the Division is ordered to file a status update that attaches (1) Respondent's most recent filing with the Commission (for the purpose of establishing service pursuant to Rule 141(a)(2)(ii)), and, if different, (2) Respondent's Form 20FR12G/A filed on December 12, 2001 (which is referenced in the OIP).³
