In the Matter of CHRISTOPHER BYUNGIN LEE

ORDER DIRECTING STATUS REPORT FROM THE DIVISION OF ENFORCEMENT

On September 27, 2022, the Securities and Exchange Commission issued an order instituting proceedings (“OIP”) against respondent Christopher Byungin Lee, pursuant to Section 15(b) of the Securities Exchange Act of 1934.¹ On June 13, 2023, the Commission issued an order directing the Division of Enforcement to file a status report by June 27, 2023, and every 28 days thereafter until it accomplished service of the OIP upon Lee.²

In its most recent status report, dated July 16, 2024, the Division of Enforcement represented that it had not been successful in serving the OIP upon Lee, and that its efforts to personally serve Lee via a process server and determine a valid address for Lee have been unsuccessful. The Division further represented that it was evaluating its next steps in this proceeding, and that it would report further by August 13, 2024. To date, the Division has not filed an additional status report.

Accordingly, IT IS ORDERED that the Division of Enforcement file a status report concerning service of the OIP by December 10, 2024, and every 28 days thereafter until service is accomplished.
