**ORDER OF SUSPENSION OF
TRADING**

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of A.C. Simmonds and Sons, Inc. (CIK No. 1554594), a revoked Nevada corporation with its principal place of business listed as King City, Ontario, Canada with stock quoted on OTC Link (previously, "Pink Sheets") operated by OTC Markets Group, Inc. ("OTC Link") under the ticker symbol ACSX, because it has not filed any periodic reports since the period ended September 30, 2014. On February 27, 2017, a delinquency letter was sent by the Division of Corporation Finance to A.C. Simmonds and Sons, Inc. requesting compliance with its periodic filing obligations, and A.C. Simmonds and Sons, Inc. did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Joshua Gold Resources, Inc. (f/k/a Enhanced Energy Solutions, Inc.) (CIK No. 1475430), a Nevada corporation with its principal place of business listed as Oakville, Ontario, Canada with stock quoted on OTC Link under the ticker symbol JSHG, because it has not filed any periodic reports since the period ended September 30, 2013. On December 16, 2015, a delinquency letter was sent by the Division of Corporation Finance to Joshua Gold Resources, Inc. (f/k/a Enhanced Energy Solutions, Inc.) requesting compliance with its periodic filing obligations, and Joshua Gold Resources, Inc. (f/k/a Enhanced Energy Solutions, Inc.) received the delinquency letter on December 30, 2015, but failed to cure its delinquencies.

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Game Plan Holdings, Inc. (CIK No. 1456090), a Nevada corporation with its principal place of business listed as Boston, Massachusetts with stock quoted on OTC Link under the ticker symbol GPLH, because it has not filed any periodic reports since the period ended September 30, 2014. On February 27, 2017, a delinquency letter was sent by the Division of Corporation Finance to Game Plan Holdings, Inc. requesting compliance with its periodic filing obligations, and Game Plan Holdings, Inc. did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of HashingSpace Corp. (CIK No. 1578731), a revoked Nevada corporation with its principal place of business listed as Scarborough, Maine with stock quoted on OTC Link under the ticker symbol HSHS, because it has not filed any periodic reports since the period ended May 31, 2015. On February 27, 2017, a delinquency letter was sent by the Division of Corporation Finance to HashingSpace Corp. requesting compliance with its periodic filing obligations, and HashingSpace Corp. did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

The Commission is of the opinion that the public interest and the protection of investors require a suspension of trading in the securities of the above-listed companies.

Therefore, it is ordered, pursuant to Section 12(k) of the Securities Exchange Act of 1934, that trading in the securities of the above-listed companies is suspended for the period from 9:30 a.m. EDT on May 25, 2017, through 11:59 p.m. EDT on June 8, 2017.
