**ORDER OF SUSPENSION OF  
TRADING**

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of American Nano Silicon Technologies, Inc. (CIK No. 1415917), a suspended California corporation with its principal place of business listed as Sichuan, China with stock quoted on OTC Link (previously, "Pink Sheets") operated by OTC Markets Group, Inc. ("OTC Link") under the ticker symbol ANNO, because it has not filed any periodic reports since the period ended June 30, 2015. On July 24, 2017, a delinquency letter was sent by the Division of Corporation Finance to American Nano Silicon Technologies, Inc. requesting compliance with its periodic filing obligations, and American Nano Silicon Technologies, Inc. did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of American Soil Technologies, Inc. (CIK No. 1031896), a Nevada corporation with its principal place of business listed as Northridge, California with stock quoted on OTC Link under the ticker symbol SOYL, because it has not filed any periodic reports since the period ended December 31, 2015. On July 24, 2017, a delinquency letter was sent by the Division of Corporation Finance to American Soil Technologies, Inc. requesting compliance with its periodic filing obligations, and American Soil Technologies, Inc. received the delinquency letter on July 27, 2017, but failed to cure its delinquencies.

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Andalay Solar, Inc. (CIK No. 1347452), a Delaware corporation with its principal place of business listed as Greenbrae, California with stock quoted on OTC Link under the ticker symbol WEST, because it has not filed any periodic reports since the period ended September 30, 2015. On July 27, 2017, a delinquency letter was sent by the Division of Corporation Finance to Andalay Solar, Inc. requesting compliance with its periodic filing obligations, and Andalay Solar, Inc. received the delinquency letter on August 4, 2017, but failed to cure its delinquencies.

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Crimson Forest Entertainment Group, Inc. (CIK No. 1529516), a Nevada corporation with its principal place of business listed as West Hollywood, California with stock quoted on OTC Link under the ticker symbol CRIM, because it has not filed any periodic reports since the period ended November 30, 2015. On July 24, 2017, a delinquency letter was sent by the

Division of Corporation Finance to Crimson Forest Entertainment Group, Inc. requesting compliance with its periodic filing obligations, and Crimson Forest Entertainment Group, Inc. received the delinquency letter on July 27, 2017, but failed to cure its delinquencies.

The Commission is of the opinion that the public interest and the protection of investors require a suspension of trading in the securities of the above-listed companies.

Therefore, it is ordered, pursuant to Section 12(k) of the Securities Exchange Act of 1934, that trading in the securities of the above-listed companies is suspended for the period from 9:30 a.m. EST on December 28, 2017, through 11:59 p.m. EST on January 11, 2018.
