**ORDER OF SUSPENSION OF
TRADING**

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Grey Fox Holdings Corp. (f/k/a Gray Fox Petroleum Corp.) (CIK No. 1546589), a Nevada corporation with its principal place of business listed as West Palm Beach, Florida with stock quoted on OTC Link under the ticker symbol GFOX, because it has not filed any periodic reports since the period ended December 31, 2015. On July 31, 2017, a delinquency letter was sent by the Division of Corporation Finance to Grey Fox Holdings Corp. (f/k/a Gray Fox Petroleum Corp.) requesting compliance with its periodic filing obligations, and Grey Fox Holdings Corp. (f/k/a Gray Fox Petroleum Corp.) did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Green Innovations Ltd. (CIK No. 1491471), a revoked Nevada corporation with its principal place of business listed as Cape Coral, Florida with stock quoted on OTC Link under the ticker symbol GNIN, because it has not filed any periodic reports since the period ended December 31, 2014. On July 31, 2017, a delinquency letter was sent by the Division of Corporation Finance to Green Innovations Ltd. requesting compliance with its periodic filing obligations, and Green Innovations Ltd. did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Red Giant Entertainment, Inc. (CIK No. 1411179), a Florida corporation with its principal place of business listed as Clermont, Florida with stock quoted on OTC Link under the ticker symbol REDG, because it has not filed any periodic reports since the period ended May 31, 2015. On April 17, 2017, a delinquency letter was sent by the Division of Corporation Finance to Red Giant Entertainment, Inc. requesting compliance with its periodic filing obligations, and Red Giant Entertainment, Inc. received the delinquency letter on April 20, 2017, but failed to cure its delinquencies.

The Commission is of the opinion that the public interest and the protection of investors require a suspension of trading in the securities of the above-listed companies.

Therefore, it is ordered, pursuant to Section 12(k) of the Securities Exchange Act of 1934, that trading in the securities of the above-listed companies is suspended for the period from 9:30 a.m. EDT on May 15, 2018, through 11:59 p.m. EDT on May 29, 2018.
