ORDER OF SUSPENSION OF TRADING

It appears to the Securities and Exchange Commission ("Commission") that there is a lack of current and accurate information concerning the securities of Bitzio, Inc. ("BTZO¹") (CIK No. 1347078), a defaulted Nevada corporation located in Chatsworth, California with a class of securities registered with the Commission pursuant to Securities Exchange Act of 1934 ("Exchange Act") Section 12(g) because it is delinquent in its periodic filings with the Commission, having not filed any periodic reports since it filed a Form 10-Q for the period ended June 30, 2016. On February 27, 2018, Corporation Finance sent a delinquency letter to BTZO requesting compliance with its periodic filing requirements, but BTZO did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 C.F.R. Section 232.301 and Section 5.4 of EDGAR Filer Manual). As of July 16, 2018, the common stock of BTZO was quoted on OTC Link operated by OTC Markets Group Inc. (formerly "Pink Sheets") ("OTC Link"), had five market makers, and was eligible for the "piggyback" exception of Exchange Act Rule 15c2-11(f)(3).

It appears to the Commission that there is a lack of current and accurate information

concerning the securities of Enerpulse Technologies, Inc. ("ENPT") (CIK No. 1495899), a

Nevada corporation located in Albuquerque, New Mexico with a class of securities registered

with the Commission pursuant to Exchange Act Section 12(g) because it is delinquent in its

periodic filings with the Commission, having not filed any periodic reports since it filed a Form

10-K for the period ended December 31, 2015. On February 28, 2017, Corporation Finance sent

a delinquency letter to ENPT requesting compliance with its periodic filing requirements, which

was delivered. As of July 16, 2018, the common stock of ENPT was quoted on OTC Link, had

six market makers, and was eligible for the "piggyback" exception of Exchange Act Rule 15c2-

11(f)(3).

The Commission is of the opinion that the public interest and the protection of investors

require a suspension of trading in the securities of the above-listed companies. Therefore, it is

ordered, pursuant to Section 12(k) of the Securities Exchange Act of 1934, that trading in the

securities of the above-listed companies is suspended for the period from 9:30 a.m. EDT on

September 11, 2018, through 11:59 p.m. EDT on September 24, 2018.
