SECURITIES EXCHANGE ACT OF 1934 Release No. 86480 / July 25, 2019

The U.S. Securities and Exchange Commission announced the temporary suspension, pursuant to Section 12(k) of the Securities Exchange Act of 1934 (the "Exchange Act"), of trading in the securities of Biohemp International Inc. (BKIT), purportedly of New York, New York, commencing at 9:30 a.m. EDT on July 26, 2019, and terminating at 11:59 p.m. EDT on August 8, 2019.

The Commission temporarily suspended trading in the securities of the foregoing company because of potentially manipulative or deceptive activity relating to the company and questions that have been raised about the accuracy and adequacy of publicly disseminated information concerning, among other things, the anticipated value of Biohemp stock. This order was entered pursuant to Section 12(k) of the Exchange Act.

The Commission cautions brokers, dealers, shareholders and prospective purchasers that they should carefully consider the foregoing information along with all other currently available information and any information subsequently issued by the company.

Further, brokers and dealers should be alert to the fact that, pursuant to Exchange Act Rule 15c2-11, at the termination of the trading suspensions, no quotation may be entered relating to the securities of the subject company unless and until the broker or dealer has strictly complied with all of the provisions of the rule. If any broker or dealer has any questions as to whether or not it has complied with the rule, it should not enter any quotation but immediately contact the staff in the Division of Trading and Markets, Office of Interpretation and Guidance, at (202) 551-5777. If any broker or dealer is uncertain as to what is required by Rule 15c2-11, it should refrain from entering quotations relating to BKIT's securities until such time as it has familiarized itself with the rule and is certain that all of its provisions have been met. If any broker or dealer enters any quotation which is in violation of the rule, the Commission will consider the need for prompt enforcement action.
