ORDER OF SUSPENSION OF TRADING

It appears to the Securities and Exchange Commission ("Commission") that there is a lack of current and accurate information concerning the securities of Green Endeavors, Inc. ("GRNE¹") (CIK No. 1487997), an active Utah corporation located in Salt Lake City, Utah with a class of securities registered with the Commission pursuant to Securities Exchange Act of 1934 ("Exchange Act") Section 12(g) because it is delinquent in its periodic filings with the Commission, having not filed any periodic reports since it filed a Form 10-Q for the period ended September 30, 2017. On January 31, 2019, the Commission's Division of Corporation Finance ("Corporation Finance") sent a delinquency letter to GRNE requesting compliance with its periodic filing requirements, which was delivered. As of June 26, 2019, the common stock of GRNE was quoted on OTC Link operated by OTC Markets Group Inc. (formerly "Pink Sheets") ("OTC Link"), had six market makers, and was eligible for the "piggyback" exception of Exchange Act Rule 15c2-11(f)(3).

It appears to the Commission that there is a lack of current and accurate information concerning the securities of Sputnik Enterprises, Inc. ("SPNI") (CIK No. 1326917), a defaulted Nevada corporation located in Orlando, Florida with a class of securities registered with the

Commission pursuant to Exchange Act Section 12(g) because it is delinquent in its periodic

filings with the Commission, having not filed any periodic reports since it filed a Form 10-Q for

the period ended September 30, 2017. On January 31, 2019, Corporation Finance sent a

delinquency letter to SPNI requesting compliance with its periodic filing requirements, but SPNI

did not receive the delinquency letter due to its failure to maintain a valid address on file with the

Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 C.F.R. Section

232.301 and Section 5.4 of EDGAR Filer Manual). As of June 26, 2019, the common stock of

SPNI was quoted on OTC Link, had four market makers, and was eligible for the "piggyback"

exception of Exchange Act Rule 15c2-11(f)(3).

The Commission is of the opinion that the public interest and the protection of investors

require a suspension of trading in the securities of the above-listed companies. Therefore, it is

ordered, pursuant to Section 12(k) of the Securities Exchange Act of 1934, that trading in the

securities of the above-listed companies is suspended for the period from 9:30 a.m. EDT on

September 12, 2019, through 11:59 p.m. EDT on September 25, 2019.
