Notice of application for an order under sections 6(c) and 23(c)(3) of the Investment Company Act of 1940 (the "Act") for an exemption from rule 23c-3 under the Act.

<u>Summary of Application</u>: Applicants request an order under sections 6(c) and 23(c)(3) of the Act for an exemption from certain provisions of rule 23c-3 to permit certain registered closed-end investment companies to make repurchase offers on a monthly basis.

<u>Applicants</u>: Arca U.S. Treasury Fund (the "Fund") and Arca Capital Management, LLC (the "Adviser").

<u>Filing Dates</u>: The application was filed on May 24, 2023.

Hearing or Notification of Hearing: An order granting the requested relief will be issued unless the Commission orders a hearing.
