Notice of an application under section 6(c) of the Investment Company Act of 1940 (the "Act") for an exemption from sections 18(a)(2), 18(c), 18(i) and section 61(a) of the Act.

<u>Summary of Application</u>: Applicants request an order to permit certain closed-end management investment companies that have elected to be regulated as business development companies ("BDCs") to issue multiple classes of shares with varying sales loads and asset-based service and/or distribution fees.

<u>Applicants</u>: T. Rowe Price OHA Select Private Credit Fund and OHA Private Credit Advisors LLC.

Filing Dates: The application was filed on July 5, 2023, and amended on September 13, 2023.

Hearing or Notification of Hearing: An order granting the requested relief will be issued unless the Commission orders a hearing.
