<u>Summary of Application</u>: Applicants request an order to permit certain closed-end management investment companies that have elected to be regulated as business development companies to issue multiple classes of shares with varying sales loads and asset-based distribution and/or service fees.

Applicants: AMG Comvest Senior Lending Fund and Comvest Credit Managers, LLC.

<u>Filing Dates</u>: The application was filed on July 1, 2024, and amended on October 7, 2024 and February 7, 2025.
