<u>Summary of Application</u>: Applicants request an order to permit certain registered closed-end investment companies that have elected to be regulated as business development companies to issue multiple classes of shares with varying sales loads and asset-based distribution and/or service fees.

Applicants: Barings LLC and Barings Private Credit Corporation.

Filing Dates: The application was filed on February 4, 2025, and amended on March 14, 2025.
