<u>Summary of Application</u>: Applicants request an order under sections 6(c) and 23(c)(3) of the Act for an exemption from certain provisions of rule 23c-3 to permit certain registered closed-end investment companies to make repurchase offers on a monthly basis.

<u>Applicants</u>: Optimize Growth Equity Fund, Optimize Premium Yield Fund and Optimize Wealth Management Inc.

<u>Filing Dates</u>: The application was filed on March 4, 2025.
