<u>Summary of Application</u>: Applicants request an order to permit certain registered closed-end investment companies that have elected to be regulated as business development companies to issue multiple classes of shares with varying sales loads and asset-based distribution and/or service fees.

<u>Applicants</u>: Star Mountain Lower Middle-Market Capital Corp., and Star Mountain Fund Management, LLC.

<u>Filing Date</u>: The application was filed on June 13, 2025.
