Notice of application for an order under sections 17(d) and 57(i) of the Investment Company Act of 1940 (the "Act") and rule 17d-1 under the Act to permit certain joint transactions otherwise prohibited by sections 17(d) and 57(a)(4) of the Act and rule 17d-1 under the Act.

<u>Summary of Application</u>: Applicants request an order to permit certain business development companies ("BDCs") and closed-end management investment companies to co-invest in portfolio companies with each other and with certain affiliated investment entities.

<u>Applicants</u>: Crestline Lending Solutions, LLC; Crestline Management, L.P.; CL Life and Annuity Insurance Company; CL Re SPC; Crestline Re SP1, a segregated portfolio of CL Re SPC; and CL Re SP2, a segregated portfolio of CL Re SPC; and certain of their affiliated entities as described in Schedule A to the application.

<u>Filing Dates</u>: The application was filed on September 13, 2024, and amended on March 7, 2025, August 6, 2025, and September 3, 2025.

Hearing or Notification of Hearing: An order granting the requested relief will be issued unless the Commission orders a hearing.
