TCW Steel City Perpetual Levered Fund LP, et al.

AGENCY: Securities and Exchange Commission (“Commission” or “SEC”).

ACTION: Notice.

Notice of application for an order under sections 17(d) and 57(i) of the Investment Company Act of 1940 (the “Act”) and rule 17d-1 under the Act to permit certain joint transactions otherwise prohibited by sections 17(d) and 57(a)(4) of the Act and rule 17d-1 under the Act.

Summary of Application: Applicants request an order to permit certain business development companies (“BDCs”) and closed-end management investment companies to co-invest in portfolio companies with each other and with certain affiliated investment entities.

Applicants: TCW Steel City Perpetual Levered Fund LP, TCW Steel City Unlevered Private Fund LP, and PNC Steel City Advisors, LLC.

Filing Dates: The application was filed on November 21, 2024, and amended on March 26, 2025, May 14, 2025 and September 9, 2025.

Hearing or Notification of Hearing: An order granting the requested relief will be issued unless the Commission orders a hearing.
