The requirement that the Exchange or their DEA provide information to the SEC within 30 days following month end pursuant to Appendix B and C of the Plan shall commence at the beginning of the Pilot Period. Notwithstanding the provisions of paragraphs (b)(2), (b)(3) and (b)(5) of this Rule, [W]with respect to data for the Pre-Pilot Period and Pilot Period, the requirement that the Exchange or DEA make [certain]Appendix B data publicly available on their website [pursuant to Appendix B and C to the Plan ]shall commence [at the beginning of the Pilot Period]on April 28,

2017. Notwithstanding the provisions of paragraph[s (b)(2), (b)(3)(C), and] (b)(~~5~~4) of this Rule, the Exchange [and]or DEA shall make Appendix C data for the Pre-Pilot Period through January 2017 publicly available on their website [pursuant to Appendix B and C to the Plan] by February 28, 2017.
