

## MEMORANDUM

**RE:** Commission's Request for Additional Information

On December 18, 2017, National Securities Clearing Corporation ("NSCC") filed advance notice SR-NSCC-2017-805 ("Advance Notice") with the U.S. Securities and Exchange Commission ("Commission") pursuant to Section 806(e)(1) of the Payment, Clearing, and Settlement Supervision Act of 2010 ("Clearing Supervision Act")<sup>1</sup> and Rule 19b-4(n)(1)(i) under the Securities Exchange Act of 1934,<sup>2</sup> in which NSCC proposes to adopt a Recovery & Wind-down Plan and related rules. The Advance Notice was published for comment in the Federal Register on January 30, 2018.<sup>3</sup>

On April 10, 2018, the Commission required additional information from NSCC pursuant to Section 806(e)(1)(D) of the Clearing Supervision Act.<sup>4</sup>

Pursuant to Section 806(e)(1) of the Clearing Supervision Act,<sup>5</sup> the Commission's period of review of the Advance Notice was tolled and shall be 60 days from the date the information required by the Commission is received by the Commission, absent an additional information request.
