NYSE Rules

Rule 128. Clearly Erroneous Executions For NYSE Equities

The provisions of sections (c), (e)(2), (f), and (g) of this Rule, as amended on September 10, 2010, shall be in effect during a pilot period until January 31, 2012 [the earlier of August 11, 2011 or the date on which a limit up/limit down mechanism to address extraordinary market volatility, if adopted, applies]. If the pilot is not either extended or approved permanent by January 31, 2012 [the earlier of August 11, 2011 or the date on which a limit up/limit down mechanism to address extraordinary market volatility, if adopted, applies], the prior versions of sections (c), (e)(2), (f), and (g) shall be in effect.
