Table 1 ENFORCEMENT MILESTONES FISCAL 2009

- Obtained orders in SEC judicial and administrative proceedings requiring securities violators to disgorge illegal profits of approximately \$2.09 billion and to pay penalties of approximately \$345 million.
- Sought orders barring 90 defendants and respondents from serving as officers or directors of public companies.
- Sought emergency relief from federal courts in the form of temporary restraining orders (TROs) to halt ongoing fraudulent conduct in 71 actions, and sought asset freezes in 82 actions.
- Filed 5 actions to enforce investigative subpoenas.
- Halted trading in securities of 192 issuers about which there was inadequate public disclosure.

In SEC-related criminal cases, prosecutors filed indictments, informations, or contempts in Fiscal 2009 in 154 cases.


