Table 1 ENFORCEMENT MILESTONES FISCAL 2010

- Obtained orders in SEC judicial and administrative proceedings requiring securities violators to disgorge illegal profits of approximately \$1.82 billion and to pay penalties of approximately \$1.03 billion.
- Sought orders barring 71 defendants and respondents from serving as officers or directors of public companies.
- Sought emergency relief from federal courts in the form of temporary restraining orders (TROs) to halt ongoing fraudulent conduct in 37 actions, and sought asset freezes in 57 actions.
- Filed 6 actions to enforce investigative subpoenas.
- Halted trading in securities of 254 issuers about which there was inadequate public disclosure.

In SEC-related criminal cases, prosecutors filed indictments, informations, or contempts in Fiscal 2010 in 139 cases.

Right to Financial Privacy

Section 21(h) of the Securities Exchange Act of 1934 [15 U.S.C. 78u(h)(6)] requires that the Commission "compile an annual tabulation of the occasions on which the Commission used each separate subparagraph or clause of [Section 21(h)(2)] or the provisions of the Right to Financial Privacy Act of 1978 [12 U.S.C. 3401-22 (the RFPA)] to obtain access to financial records of a customer and include it in its annual report to the Congress." During the fiscal year, the Commission issued no subpoenas under Section 21(h)(2)(A)(3). 

The volume of complaints concerning problems with advance fee fraud ranked first among all complaint categories in FY 2010. OIEA also received a combined total of 1,437 complaints concerning account administration issues (ranking third and fourth on the list).
