#### TABLE 1 ENFORCEMENT MILESTONES FISCAL 2016

- Obtained orders in SEC judicial and administrative proceedings requiring securities violators to disgorge illegal profits of approximately \$2.809 billion and to pay penalties of approximately \$1.273 billion.<sup>1</sup>
- Sought orders barring 113 defendants and respondents from serving as officers or directors of public companies.
- Sought emergency relief from federal courts in the form of temporary restraining orders (TROs) to halt ongoing fraudulent conduct in 24 actions, and sought asset freezes in 33 actions.
- Filed 7 actions to enforce investigative subpoenas.
- Halted trading in securities of 199 issuers about which there was inadequate public disclosure.

In SEC-related criminal cases, prosecutors filed 109 indictments, informations, or contempts in Fiscal Year 2016.
