

List of Security-Based Swap Dealers and Major Security-Based Swap Participants

A security-based swap dealer (SBSD) or major security-based swap participant (MSBSP) that has timely submitted a complete Form SBSE-C and a complete Form SBSE, Form SBSE-A or Form SBSE-BD, as applicable, and has not withdrawn its registration is conditionally registered with the Commission. An SBSD or MSBSP remains conditionally registered until the Commission grants or denies on-going registration.

The Division of Trading and Markets has compiled the below list of SBSDs and MSBSPs who have filed applications for registration as SBSDs or MSBSPs, accordingly. In addition, the list also indicates which of the listed SBSDs or MSBSPs have withdrawn the registration or otherwise deregistered. The list of SBSDs and MSBSPs is compiled based on a search for Form SBSE-C and Forms SBSE, SBSE-A, SBSE-BD and SBSE-W filings through the Commission's Electronic Data Gathering, Analysis and Retrieval system. All information in the list is taken from the applications, including the UIC/LEI, if provided. **This list was prepared by staff of the Division of Trading and Markets.
