

Valeo Financial Advisors, LLC (“we,” “us” or “our”) is registered with the U.S. Securities and Exchange Commission (“SEC”) as an investment adviser. Investment advisory services and compensation structures differ from those of a registered broker-dealer, and it is important that you understand the differences.

### **What investment services and advice can you provide me?**

We are a Fiduciary. We provide investment advisory services, including discretionary and non-discretionary investment management and financial planning services to individuals, trusts, and estates (our “retail investors”).

When a retail investor engages us to provide investment advisory services we shall monitor, on a continuous basis, the investments in the accounts over which we have authority as part of our investment management service. Furthermore, when engaged on a discretionary basis, we shall have the authority, without prior consultation with you (unless you impose restrictions on our discretionary authority), to buy, sell, trade, and allocate the investments within your account(s) consistent with your investment objectives. Our authority over your account(s) shall continue until our engagement is terminated.

We offer investment management and financial planning services as part of our standard investment advisory engagement. When we provide financial planning services, we rely upon the information you provide for our financial analysis and may not be able to verify any such information while providing this service.

We do not limit the scope of our investment advisor services to proprietary products or a limited group or type of investment.

### **What Fees will I pay?**

When engaged to provide investment advisory services, we shall charge a fee calculated as a percentage of your overall Net Worth (our “Net Worth Fee”). Our annual Net Worth Fee ranges from 0.40% to 0.10% depending upon your cumulative Net Worth. New clients will generally incur a one-time transition fee equal to one full quarterly fee, billed at the inception of the relationship, and we generally require a minimum annual fee of \$10,000 for our services.

We may offer an “Emerging Client” program to clients who have a net worth, investment portfolio, or other financial situation that does not meet our minimum requirements for a traditional relationship. These clients pay a one-time project fee. Until the client’s manageable investment portfolio exceeds \$750,000 or unique circumstances change, we will not charge an ongoing quarterly fee. Instead, we ask these clients to make an optional annual charitable contribution to The Valeo Foundation, a 501(c)(3) charity.

We typically deduct our Net Worth Fee from one or more of your accounts in advance, on a quarterly basis. Because our Net Worth Fee is calculated as a percentage of your total Net Worth, the more assets you have in your advisory account, the more you will pay us for our investment management services. Therefore, we have an incentive to encourage you to increase your Net Worth.

**Other Fees and Costs:** Your investment assets will be held with a qualified custodian. Custodians generally charge brokerage commissions and/or transaction fees for effecting certain securities transactions. In addition, relative to all mutual fund and exchange traded fund purchases, certain charges will be imposed at the fund level (e.g., management fees and other fund expenses).

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

**What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?**

When we function as your investment adviser, we must act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice, we provide you with. As an example, we may recommend a particular custodian to custody your assets, and we may receive support services and/or products from that same custodian, certain of which assist us to better monitor and service your account while a portion may be for the benefit of our firm.

**How do your financial professionals make money?**

Our financial professionals are generally compensated as a percentage of the fees you pay us. You should discuss your financial professional's compensation directly with your financial professional.
