What fees will I pay?

This fee is calculated from a sliding fee schedule at an annual rate of 1.0% on the first \$5 million, 0.80% on the next \$5 million, 0.60% on the next \$5 million, and 0.50% on amounts over \$15 million in your account. The more assets there are in your account, the more you will pay in fees, and we may therefore have an incentive to encourage you to increase the assets in your account. Our fee does not include (and you will pay separately) any applicable charges imposed by custodians, brokers and other third parties such as brokerage commissions, transaction fees, custodial fees, wire transfer and electronic fund fees, and other fees and taxes on your account and on the securities transactions in your account. Money market funds, mutual funds, and ETFs also charge their own internal management fees. Financial Planning Services and Budget Coaching Services are complementary to our Investment Management Services clients with portfolios of \$500,000 or more.
