We would consider utilizing private funds in rare circumstances. Generally, our minimum portfolio size is \$2 million. This fee, which is payable quarterly in advance, is calculated from two sliding fee schedules: 1) for portfolios with \$2 million or more under our management, we charge an annual rate of 0.85% on the first \$2 million, 0.65% on the next \$3 million, 0.50% on the next \$5 million, and 0.30% on amounts over \$10 million in your account. 2) for portfolios under \$2 million, we charge an annual rate of 1.0% on the first \$1 million, and 0.70% on the next \$1 million in your account. We generally require a minimum fee of \$4,250 per quarter for advisory services. The more assets there are in your account, the more you will pay in fees, and we may therefore have an incentive to encourage you to increase the assets in your account.
