Tenjin AI Capital Advisors LLC is registered with the Securities and Exchange Commission as an investment adviser. Brokerage and investment advisory services and fees differ and it is important for you to understand the differences. Free and simple tools are available to research firms and financial professionals at [Investor.gov/CRS](https://www.investor.gov/CRS), which also provides educational materials about broker-dealers, investment advisers, and investing.

## ***What investment services and advice can you provide me?***

---

We offer investment advisory services to retail investors exclusively through the internet, Investment Outlook/Research, Non-Discretionary Investment Advice, and Discretionary Investment Management driven by a proprietary online platform known as TenjinAI™. When we are granted investment discretion through our Discretionary Investment Management service tier, our discretionary authority to buy, sell, and otherwise transact in securities in your account(s) is granted in our advisory agreement and is only limited by your reasonable restrictions or our mutual ability to terminate the advisory agreement.

When providing non-discretionary advisory services through our Investment Outlook or Non-Discretionary Investment Advice service tiers, you make the ultimate decision regarding the purchase or sale of investments. We only offer advice with respect to certain types of investments, which generally include individual stocks and options, exchange traded funds ("ETFs"), and mutual funds. We do not offer proprietary products.

We do not have a minimum account size to open an account in TenjinAI. However, investment strategies offered by TenjinAI may have minimum investment requirements.

Regular monitoring of your account(s) is included as part of our Non-Discretionary Investment Advice and Discretionary Investment Management service tiers, which is conducted on an ongoing basis through the TenjinAI™'s proprietary algorithms. It is important that you keep your online profile updated with your current financial situation so the TenjinAI™ platform can adjust its recommendations and management as necessary.

## ***What fees will I pay?***

---

Retail investors will generally incur the following fees charged by us:

Investment Research Service: Fixed fees that approximate in the range of \$4.99-\$29.99 per month based on the level of the service.

Non-Discretionary Investment Advisory Service: A fixed fee that approximate in the range of \$29.99-\$49.99 per month or a tiered variable fee based on the amount of AUA and the level of the service in the range of 0.15%-0.30% of AUA. Fees may be charged on a monthly basis or on an annual basis based on customer's preference in advance of service.

Discretionary Investment Management Service: A tiered fee in the range of 0.50% and 2.00% of AUM per year based on the amount of AUM and the level of service. Management Fees are usually debited automatically on a monthly basis from the managed account by the broker/custodian on our behalf. Certain specialized discretionary services are offered for qualified clients and corporations only with higher minimum investments, higher risk profile and suitability. An additional performance-based fee ("Incentive Allocation"), ranging from 10% to 20% of realized and unrealized income and gains of the account may be charged for these accounts, subject to a high watermark, as described in the Offering Documents. Fees for our Investment Research and Investment Advisory are charged in advance, and asset-based fees are charged monthly in arrears. In addition, retail investors will also generally incur the following fees and costs charged by third-parties: custodian fees, account maintenance fees, product expenses such as internal expense ratios, and transaction charges. Once a payment has been made for the current term, it is non-refundable. However, customers have the freedom to

cancel renewals of premium services for future periods before the start of the next term. This policy ensures the continuation of our commitment to providing exceptional investment guidance while offering flexibility in subscription management. When we charge an asset-based fee, the more assets there are in your account(s), the more you will pay in fees, and we may therefore have an incentive to encourage you to increase the assets in your account(s).

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

## ***What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?***

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

The custodians we recommend provide us various products and services that are intended to directly benefit you, us, or both of us. To the extent a custodian provides us products or services that don't directly benefit you, this creates an incentive to recommend that custodian. To learn how we address this incentive, please refer to Item 12 of our ADV Part 2A brochure.

Because different portfolios are charged at different annual rates, we have a conflict of interest in that we are incentivized to recommend and manage portfolios that will result in higher compensation.

## ***How do your financial professionals make money?***

Our financial professionals are compensated based on a fixed base salary plus a discretionary bonus. Compensation is not based on product sales or commissions, and does not vary based on client-related services.
