

Form ADV Part 3: *Relationship Summary* - TVAMP, LLC

Introduction

TVAMP, LLC (TVAMP) is an Investment Adviser registered with the U.S. Securities and Exchange Commission. We offer our clients investment advisory services. Clients should understand that the services we provide and fees we charge are different than those of a broker-dealer, and that it is important to understand the difference between the two. Free and simple tools are available to research firms and financial professionals at www.investor.gov/CRS, which also provides educational materials about broker-dealers, investment advisers, and investing.

What Investment Services and Advice Can You Provide me?

Description of Services: We offer investment advisory services to retail investors. Our investment advisory services include: Asset Management Services and Financial Planning and Consulting Services.

Asset Management Services: TVAMP provides asset management services which involves us managing and trading your designated account(s). TVAMP will discuss your investment goals and design a strategy to try and achieve your investment goals. TVAMP will continuously monitor your account when providing asset management services and contact you at least annually to discuss your portfolio. We offer asset management services through both wrap fee programs and non-wrap fee programs. For more information please see **Item 4** of our **Form ADV Part 2A**. When providing asset management services you can choose whether you'd like us to provide services on a **discretionary** basis (we will have the authority to determine the type and amount of securities to be bought or sold in your account) or a non-discretionary basis (we will have to confirm any trades in your account with you before we place them). For more information please see **Item 16 of our Form ADV Part 2A**.

Financial Planning & Consulting Services: We also provide financial planning and consulting services. Financial planning services involve us creating a written financial plan for you which covers mutually agreed upon topics. Financial consulting is used when a written financial plan is not needed. It involves one time and/or ongoing meetings to discuss your financial situation. Please see **Item 4** of our **Form ADV Part 2A**.

Retirement Plan Participant Advice: If your retirement plan utilizes our Retirement Plan Participant Advice Service, we are available at your request to provide one-on-one advice to you as a retirement plan participant regarding your investment options under the plan. Please see **Item 4 of our Form ADV Part 2A**

Limited Investment Offerings: We do not primarily recommend one type of security to clients. Instead, we recommend any product that may be suitable for each client relative to that client's specific circumstances and needs. However, we are limited in investment selection in that we can only invest your account in securities which are available on your custodian/broker-dealer's platform. When providing you services, we do not recommend or offer advice on any proprietary products.

Account & Fee Minimums: TVAMP requires a minimum of \$50,000 in order to open an account. To reach this account minimum, clients can aggregate all household accounts. The minimum hourly or fixed fee charged for financial planning or consulting services provided on an hourly basis is generally \$500. Exceptions can be granted at the discretion of the advisor.

What Fees Will I Pay?

Description of Principal Fees & Costs: Fees charged for our asset management services are charged based on a percentage of assets under management, billed in advance on a quarterly calendar basis, and calculated based on the fair market value of your account as of the last business day of the previous billing period. The annual fee for asset management services will be based upon a fee schedule which will generally range between 1.00% and 2.00%. Exceptions can be granted at the discretion of the advisor. Because our fee is based upon the value of your account we have an incentive to recommend that you increase the level of assets in your account. We utilize wrap fee and non-wrap fee programs. Under a wrap fee program the fee you pay us covers both our advisory services and the transaction fees imposed by the broker-dealer therefore tends to have a higher management fee. Under a non-wrap fee program you will be charged transaction costs separately. You may also be charged management fees by the funds we invest in within your account. For more information about the fees we will charge you and expenses you may incur please see **Item 5 of our Form ADV Part 2A**.

Financial planning and consulting services are provided under an hourly fee arrangement. An hourly fee of \$500 per hour is charged by TVAMP for financial planning and/or consulting services under this arrangement. TVAMP also provides financial planning and consulting services under a fixed fee arrangement. The minimum fixed fee is generally \$500, and the maximum fixed fee is generally no more than \$8,000 (however larger fees may be required for more complex situations). You will pay in advance a mutually agreed upon retainer that will be available for TVAMP to bill hourly fees against for our financial planning services. We will bill our financial planning fees to you on a monthly basis. TVAMP also offers ongoing consulting services priced based upon a percent of the assets under advisement or on an annual subscription basis that can range up to \$6,000 per year.

Additional Information: You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

**What are your legal obligations to me when acting as my investment adviser?
How else does your firm make money and what conflicts of interest do you have?**

Standard of Conduct: When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you.

Retirement Plan Rollover Recommendations – TVAMP does not recommend rollovers to our clients or prospects. The firm's activities will be strictly limited to educating clients and prospects as to their options.

When we provide asset management services, we will ask that you establish an account with LPL Financial to maintain custody of your assets and to effect trades for your account. Our recommendation to use LPL Financial is not based solely on your interest of receiving the best execution possible. We also recommend LPL Financial because they provide us with research, products and tools that help us manage and further develop our business operations. As a result, we do not have to pay for such benefits, which save us money; however, these arrangements create a conflict of interest. See **Item 12 of our Form ADV Part 2A** for more information about our arrangements with LPL Financial. We actively manage our own personal accounts while at the same time managing your accounts and other client accounts. This creates different conflicts of interest for which we have developed procedures to mitigate and control for those conflicts. For more information see **Item 11 of our Form ADV Part 2A**. When we recommend that you utilize a third-party money manager we will receive a percentage of the fee which they collect from you. This creates a conflict of interest as we have an incentive to recommend managers who have such arrangements with us. Some of our investment adviser representatives also serve as insurance agents. Through their role as such they may sell, for commissions, various insurance products. We have a conflict of interest in recommending these products to you because of the potential for additional revenue.

How do your financial professionals make money?

Description of Salary/Payment of Representatives: We compensate our IARs based on the level of assets that they bring in to TVAMP. This creates a conflict of interest as it gives your representative an incentive to recommend you invest more in your account with us due to the potential for increased payments.

Our representatives also serve as licensed insurance agents. When acting in this capacity, the representative will receive commissions for selling insurance products. This creates a conflict of interest when the representative recommends you purchase insurance products through him or her. Our representatives also serve as registered representatives of LPL Financial, an SEC registered broker-dealer. Your representative may offer you brokerage services through LPL and/or investment advisory services through TVAMP. When acting in this separate capacity, the representative will receive transaction-based compensation for selling securities which creates conflicts of interest.
