Investment advisory and brokerage services and fees differ, and it is important for you to understand the differences. What investment services and advice can you provide me?

We offer customized investment advisory and financial planning services, selection of other advisers, and educational seminars and newsletters to retail investors. We offer advice on a full suite of securities, including equities, fixed income, mutual funds, ETFs, annuities, REITs, digital assets, options, and similar investments utilizing Biblically responsible investing principles. Our services are generally provided on a discretionary basis, which means that we have the power to buy and sell securities for your account without your prior consent. This authority is usually unlimited and remains in effect until you revoke it. We may provide non-discretionary investment advice, where we make investment recommendations to you and you decide whether to implement the recommendation. For financial planning services, we do not exercise discretionary authority or require you to use certain advisors. We do give advice on proprietary investment products.

We provide continuous and regular supervision of advisory client assets as part of our standard service to you. In addition, we will conduct ad hoc reviews if you change your objectives or risk tolerance, upon significant market and economic events, or if we change our investment strategy.

We require a minimum account size of \$100,000, which can be waived in unique or special circumstances

What fees will I pay?

Our asset-based are calculated as a percentage of the assets under our management, so our fees will rise and fall with the value of the assets we manage for you. While our fees may reduce the amount of your assets available for investment, we believe they are justified by our services and attention to your needs. Moreover, we believe our interests are aligned with yours in this type of fee structure. Nonetheless, a conflict of interest may appear in that we are economically incented to recommend that you place more assets in your account in order to increase the value of your portfolio, because as the value increases, so do our fees.

In addition to our fees, you may be charged transaction or asset-based fees by your custodian for its services. These fees vary depending on the custodian. Under a transaction fee arrangement, the more transactions effected in your account, the more fees you will pay, and high activity in your account does not assure positive portfolio performance. For custodians that charge their fees based upon a percentage of your assets, such fees may be more than would be the case if you are charged a transaction-based fee. Please be mindful of the effect of your portfolio size, the level of activity, and the rate of custodian asset-based pricing. Generally, large portfolios would be disadvantaged by paying an asset-based custodian fee versus a transaction-based fee. Some securities carry additional costs, such as mutual funds and ETFs. Financial planning fees will be charged at an hourly or fixed rate as agreed upon by you and our firm.

There are additional fees such as internal fees and expenses charged by mutual funds (i.e., 12b-1 distribution fees and management fees that are assessed within the mutual fund) and exchange-traded funds, third-party separate account manager fees, fees imposed by private placements and pooled investment vehicles, product-level fees and commission for insurance-related products, postage and handling, transfer taxes, SEC fees for sales of securities. Also, with certain investments such as variable annuities, you may have to pay fees such as "surrender charges" to sell or redeem the investment.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means:

- We are affiliated and under common control and ownership with Solomon Fund I GP, LLC ("Solomon Fund GP"). Solomon Fund GP serves as the General Partner to the private fund managed by our firm. The General Partner offers third-party investors and clients of our firm direct access to the private fund. Due to our affiliation with the General Partner, we have a financial incentive to recommend that clients invest in the private fund. We have a conflict of interest in that we assess fees within the private fund and for the client's entire portfolio value. To address this conflict, we will exclude the private fund value from the assets-under-management fee assessed to your managed portfolio.
- Solomon Fund GP also owns an equity ownership position in Wildlife Partners, LLC. As such, we have an economic incentive to recommend investments in private funds sponsored by Wildlife Partners, LLC, through the Solomon Fund, as the fees in the Solomon Fund are greater than what would otherwise be charged to an advisory client of our firm.
- Certain of our financial professionals are (i) licensed to sell insurance, and/or (ii) registered with a broker-dealer, both of which create conflicts of interest regarding compensation and time spent servicing client accounts.

Our financial advisors are paid either a percentage of the fees we collect from you or a salary and bonus. Our financial advisors may be paid sales commission for the sale of mutual funds or other securities or insurance products. We are incentivized to recommend that you add additional assets to your advisory account. We do not receive non-cash compensation.
