

Client Relationship Summary – August 2024

Tiempo Capital Partners is an investment adviser registered with the U.S. Securities and Exchange Commission. Investment advisory and brokerage services and fees differ; therefore, it is important for you to understand the differences.

What investment services and advice can you provide me?

We offer investment management services and family office consulting and advisory services to retail investors. As part of our standard investment management services, we monitor our clients' portfolio holdings and the overall asset allocation strategy on an annual basis, or when market conditions or other triggers would warrant a review. Triggers include a change of investment objectives, a change in employment, or a change in recommended asset allocation weightings. Our family office consulting and advisory services entail integrated family office technology enablement, creation of a strategic family office plan, outsourced chief investment officer and investment management support, and goal oriented family governance to achieve long-term vision.

We offer our investment management services on a discretionary basis. Discretionary asset management allows us the limited authority to buy and sell investments in your account without asking you each time a transaction is placed. Our level of authority is determined at the beginning of our relationship with you in our advisory agreement, but can be changed upon request.

We provide investment recommendations and construct portfolios using a wide array of securities types to meet the investment objectives of clients. We require a cumulative minimum account of \$1 million for opening or maintaining accounts for retail investors.

What fees will I pay?

Principal Fees: We are compensated for providing the investment management services by charging an ongoing asset-based fee that ranges from 0.30% to 0.90% per annum depending on the size of the account. The fees are paid quarterly in arrears, based on the value of portfolio assets of the account on the last business day of the quarter. Certain Qualified Clients, as defined by the SEC, pay a performance-based fee of 10% of the gains in the account for the calendar year. The performance-based fee is subject to a hurdle rate of 8.0% and a high water mark, and is calculated at the end of the calendar year and deducted concurrent with the fourth quarter management fee. The more assets there are in your advisory account, the more you will pay in fees, and we may therefore have an incentive to encourage you to increase the assets in your account. Our family office consulting and advisory services are based on a fixed annual fee of \$325,000 payable quarterly, in arrears. Additionally, we charge a single up-front setup fee of \$50,000 that is due upon signing the agreement. Tiempo Capital Partners' fees are negotiable based at the firm's discretion.

Other Fees and Costs: Tiempo Capital Partners' fees are exclusive of brokerage commissions, transaction fees, and other related costs and expenses which shall be incurred by the client. You may incur certain charges imposed by custodians, brokers, custodial fees, odd-lot differentials, transfer taxes, wire transfer and electronic fund fees, and other fees and taxes on brokerage accounts and securities transactions. All fees paid to us for investment advisory services are separate and distinct from the fees and expenses charged by mutual funds and ETFs to their shareholders, which are disclosed in the funds' prospectuses.

Additional Information: You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce the amount of money you make on your investments over time. Conversation Starter – Ask Your Financial Professional:

Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here is an example to help you understand what this means.

Tiempo Capital Partners' Investment Advisor Representatives may trade for their own accounts securities that are being traded for client accounts at or about the same time. To mitigate the conflict of interest in such circumstances, Tiempo Capital Partners' policy is to require the trading of all relevant client accounts prior to the trading of their own accounts. The Chief Compliance Officer examines personal trading activities of Tiempo Capital Partners' personnel to verify compliance with this policy. **These arrangements and additional information about other conflicts of interest are discussed in more detail in our Form ADV Part 2A.**

Conversation Starter – Ask Your Financial Professional:

How might your conflicts of interest affect me, and how will you address them?

How do your financial professionals make money?

Our Investment Advisor Representatives are compensated through the receipt of a portion of revenue we receive for the advisory services we provide. The portion paid to your Investment Advisor Representative generally does not vary based on the type of investments that are recommended.

Do you or your financial professionals have legal or disciplinary history?
