ZEGA Investments, LLC is registered with the Securities and Exchange Commission as an investment adviser and, as such, we provide advisory services rather than brokerage services. Brokerage and investment advisory services and fees differ and it is important for you, our client, to understand the differences. Additionally, free and simple tools are available to research firms and financial professionals at [Investor.gov/CRS](https://investor.gov/CRS). This document is a summary of the services and fees we offer to “retail” investors, which are natural persons who seek or receive services primarily for personal, family, or household purposes.

What investment services and advice can you provide me?

We offer the following investment advisory services to retail investors: **Portfolio Management Services** which incorporates financial planning. We are also a **Sponsor and Manager of a Wrap Fee Program**. We also act as a sub-advisory for other investment advisory firms. Account Monitoring: If you open an investment account with our firm, as part of our standard service we will monitor your investments on a quarterly basis, at a minimum, and ensure all investments fit your risk profile.

Investment Authority: We manage investment accounts on a *discretionary* basis whereby **we will decide** which investments to buy or sell for your account.

Investment Offerings: We provide advice on various types of investments. Although we generally recommend investments in U.S. exchange traded options for major U.S. indexes, our services are not limited to a specific type of investment or product.

Account Minimums and Requirements: In general, we do not require a minimum dollar amount to open and maintain an advisory account; however, we have the right to terminate your account if it falls below a minimum size which, in our sole opinion, is too small to manage effectively. We impose a minimum fee for you to maintain an advisory account with us.

What fees will I pay?

The following summarizes the principal fees and costs associated with engaging our firm for investment advisory services. Asset Based Fees - Payable quarterly in arrears. Since the fees we receive are asset-based (i.e. based on the value of your account), we have an incentive to increase your account value;

Wrap Program Fees - Payable quarterly in arrears, based on the value of the account at the end of the quarter. Asset-based fees associated with a wrap fee program generally include most transaction costs and fees to a broker-dealer or bank that has custody of the assets; therefore, the asset-based fee will be higher than a typical asset-based advisory fee in a non-wrap program. Since our firm pays the transaction costs associated with securities transactions in your account, we have an incentive to minimize the trading in your account. Currently, ZEGA has no clients in the WRAP program;

Depending on the type of account you open, you may pay additional fees and/or expenses such as commissions

charged by the broker-dealer/custodian. Other possible common fees and costs applicable to our clients may include: Custodian fees; Account maintenance fees; Fees related to mutual funds and exchange-traded funds; and other product-level fees associated with your investments.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

Key Questions to Ask Your Financial Professional

- **Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?**

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

Because many advisors revenue (including ZEGA'S) is derived from asset-based fees, advisors have an incentive to grow your account as much as possible. This could cause an advisor to take overly aggressive positions, in conflict with your interests, in an attempt to grow your account. ZEGA will review every clients' risk profile on a quarterly basis to ensure that all investments are consistent with their investment decisions. For wrap accounts, there is an incentive for us to minimize the trading since we pay for the transaction costs (i.e., commissions).
