## Exhibit to Form CRS

Forefront Analytics, LLC is required to update its Client Relationship Summary (Form CRS) whenever information in the Form CRS becomes materially inaccurate. This Exhibit provides a summary of the material changes that have occurred since the last filing of the Form CRS dated, March 29, 2021:

- We have retained our minority interest in AlphaClone, Inc. a formally registered investment adviser, although they are no longer offering any products, therefore references to ownership have been removed.

We are registered with the U.S. Securities and Exchange Commission as an investment adviser. Brokerage and investment advisory services fees differ, and it is important for you to understand the differences. ## What investment services and advice can you provide me?

Our firm offers investment advisory services, which are fully described in our Form ADV Part 2A ("Disclosure Brochure"). Our services include investment management, consulting, investment advisory and other services. As part of our investment management services, we monitor client portfolios on a continuous and ongoing basis. Investment consulting recommendations, however, are not actively monitored, unless specifically agreed upon. We accept discretionary and/or non-discretionary authority to implement the recommended transactions in client accounts. The level of discretion is determined in our agreement and there are no material limitations on the authority. For non-discretionary services, you make the ultimate decision regarding the purchase or sale of investments. We do not offer advice only with respect to proprietary products - we also offer advice on alternative investment vehicles, exchange-traded funds, mutual funds, independent investment managers, individual debt and equity securities, derivatives and/or other securities or investments in accordance with the clients' individual investment objectives. We may recommend that certain clients invest in private placement investments, which may include, without limitation, debt, equity, and/or pooled investment vehicles when consistent with the clients' investment objectives. Our services are not subject to a minimum fee or account size.

## What fees will I pay?

We offer our services on a fee basis. We charge a fixed or hourly fee for investment consulting, and a fee based upon assets under management for investment management and wealth management services. The frequency and manner in which these asset-based fees are charged (e.g., monthly / quarterly, in advance / arrears) varies based on our individual negotiations with our clients.

In addition to the advisory fees paid to us, you also incur certain charges imposed by third parties, such as broker-dealers, custodians, etc. These additional charges can include custodial fees, fees charged by independent managers, charges imposed directly by a mutual fund, exchange-traded fund, or private fund, which are disclosed in the fund's prospectus or private placement memorandum (e.g., fund management fees, performance related fees, and other fund expenses), deferred sales charges, odd-lot differentials, transfer taxes, wire transfer and electronic fund fees, and other fees and taxes on brokerage accounts and securities transactions. Additionally, you could incur brokerage commissions and transaction fees. Such charges, fees and commissions are exclusive of and in addition to our fee.

The more assets there are in your advisory accounts, the more you will pay in fees, so the firm may therefore have an incentive to encourage you to increase the assets in your account or manage them in a way where the firm could charge higher fees. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. ### **What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?**

**When we act as your investment adviser**, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

- **Proprietary Products:** We may recommend investments in private funds that are managed by us. This results in an incentive for us to recommend (initially and ongoing) that investment.
- **Affiliated Investment Adviser:** Our firm is under common control with an affiliated SEC registered investment adviser, GKFO, LLC ("GKFO"). Our principal and certain supervised persons also serve in the same or similar capacities for GKFO. A conflict of interest exists to the extent that we recommend the services of GKFO and our principal or supervised persons receive a portion of the investment advisory fees or other additional compensation by virtue of their position with GKFO. Our investment process is structured to provide recommendations that are made in our clients' best interest.

**Affiliated Investment Adviser:** Our firm owns a 30% interest in an affiliated SEC registered investment adviser which serves institutional investors, StoneRidge Investment Partners, LLC ("SRIP"). The ownership arrangement between our firm and SRIP entitles Forefront to three out of ten board seats. Our firm is also under an investment management agreement with SRIP to provide services in a non-discretionary capacity. By virtue of our agreement with SRIP our principal serves as Co-Chief Investment Officer of SRIP and certain supervised persons serve SRIP in the same or similar capacities as our firm. A conflict of interest exists to the extent that we recommend the services of SRIP and Forefront receives a portion of the investment advisory fees or other additional compensation or benefit by virtue of its position with SRIP.
