What investment services and advice can you provide me?
<b>Services:</b> We offer investment advisory services to retail investors. These services include investment advisory solutions. We work closely with you to identify your investment goals and objectives, as well as risk tolerance and financial situation in order to develop an investment approach.
<b>Accounts, Investments, and Monitoring:</b> We provide services to high net worth individuals. We primarily use directly originated private credit securities when constructing portfolios. We make available or offer advice with respect to only a limited menu of products or types of investments. As part of our standard services, we monitor portfolios and securities in accounts on a regular and continuous basis. We also offer to meet with you at least annually, or more frequently, depending on your needs.
<b>Investment Authority:</b> We provide our services on a perpetual and discretionary basis. We execute investment recommendations in accordance with your investment objectives without your prior approval of each specific transaction. Our engagement will continue until you notify us otherwise in writing.
<b>Account Minimums &amp; Other Requirements:</b> We generally require a minimum account size of \$10,000,000 in order to effectively implement our investment process. This amount may be waived or reduced at our sole discretion.

## Fees, Costs, Conflicts, and Standard of Conduct

What fees will I pay?
<b>Asset-Based Fees:</b> Our asset-based fees for investment management range up to 1.25% annually. This fee is collected on a quarterly basis and calculated as a percentage of the value of the cash and investments in your account[s] that we manage. This presents a conflict of interest as we are financially incentivized to encourage you to place more assets in your advisory account as you will pay more in advisory fees.
<b>Other Fees &amp; Costs:</b> In addition to our advisory fee, you will also be responsible for platform fees, custody fees, account administrative fees, fees and expenses related to individual securities and applicable securities transaction fees.
<b>Additional Information:</b> <b>You will pay fees and costs whether you make or lose money on your investments.</b> Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying. **What are your legal obligations to me when acting as my investment adviser?  
How else does your firm make money and what conflicts of interest do you have?**

*When we act as your investment adviser, we have to act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here is an example to help you understand what this means.*

We receive different types of fees, such as asset-based and performance-based fees. Managing retail clients and proprietary funds that are charged different types of fees creates conflicts of interest between us and our clients. For example, charging performance-based fees could incentivize the Advisor to allocate more favorable investments to those clients or funds being charged a performance-based fee.
