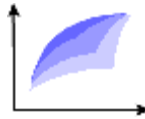

EDUCATION AND BUSINESS BACKGROUND: SUSAN F. SHARIN

Susan Sharin, born 1946, graduated Phi Beta Kappa cum laude from William Smith College in 1967. She has more than thirty years of experience as a finance professional. From 1977 through 1989, Susan Sharin was a stockbroker and first vice president with several major investment banking firms. Since 1989, she has been an independent investment advisor.

In the philanthropic arena, Susan Sharin founded a nonprofit organization in 1989, raised and managed the funds, and served as treasurer on the board of directors and executive director of the organization. The corporation, College Express Project Inc., successfully completed its mission (helping twelve disadvantaged children enter and complete college) and terminated in 1995.

EDUCATION AND BUSINESS BACKGROUND: WILLIAM J. BERNSTEIN

William Bernstein, born 1948, graduated maxima cum laude from LaSalle College in 1969. He earned the Ph.D. in organic chemistry from University of California, Berkeley in 1972 and an M.D. from the University of California, San Francisco in 1976. He retired from the active private practice of neurology in 2005.

William Bernstein has over twenty-five years of investment experience, has conducted research into portfolio theory, edited an online journal of asset allocation and portfolio theory since 1995, and has written three books on asset allocation and portfolio management: *The Intelligent Asset Allocator*, published in 2000; *The Four Pillars of Investing*, published in 2002; and *The Investor's Manifesto*, published in 2009. In 1998, William Bernstein and Susan Sharin formed the investment advisory firm Efficient Frontier Advisors LLC to manage individual and institutional portfolios.

William Bernstein currently is on the review board of the research foundation of the CFA Institute and the review panel of *Financial Analysts Journal*. He is frequently quoted in national and regional publications, including *The Wall Street Journal* and *The New York Times*, and has published articles in *Financial Analysts Journal*.
