EDUCATION BACKGROUND AND BUSINESS EXPERIENCE

In addition, all personnel providing investment advisory services are required to have financial, analytical or portfolio management experience. Kingfisher investment personnel are expected to have passed all relevant securities examinations and/or obtained the Chartered Financial Analyst designation as required by state securities regulations or have sufficient financial, analytical, portfolio management experience or educational background to be eligible for a waiver of such state regulations.
